

Essential Training Standards

Member statement of commitment

The Forest Grower members of AFPA and Contractor members of AFCA are committed to ensure that all workers in the forests we manage or work in hold a statement of attainment of approved nationally recognised units of competency when undertaking any task that involves:

- Driving heavy plant or log trucks
- Using hand held motorised equipment
- Ground based workers working near heavy plant and tree falling operations.

We endorse the agreed units of competence and commit to ensuring the list is reviewed annually to ensure its ongoing relevance.

We understand that the costs associated with training delivery are significant and will work collaboratively to ensure training and assessment services are delivered efficiently and effectively and funded training opportunities are maximised.


New workers to the industry when undertaking the above tasks must be supervised and undergoing training. All workers must hold the relevant statements of attainments 6 months after commencing work.

For existing workers members will accept pre-existing training against a national competency which may be verified by a statement of attainment, all through previously recognised State based industry standards.


We recognise that Forestworks FOLS Skill Verification Program is a useful online tool which companies may use to demonstrate conformance with this commitment.

Approved units of competency

All workers must hold a statement of attainment for the following units of competency (or their predecessors) relevant to their job role:

- FWPCOR2205 Follow OHS policies and procedures AND FWPCOR2203 Follow environmental care procedures; OR
- FWPCOR3201 Implement safety, health and environmental policies and procedures; OR
- FWPCOR4201 Monitor safety health and environment policies and procedures.

In addition to these general requirements, they must also hold a statement of attainment for a unit of competency (or its predecessor) related to the hazardous activity they are conducting as below:
